In consideration for the HDG Extreme Boat Dockin' Committee and HDGinBloom providing the undersigned a space or booth at the 2025 HDG Extreme Boat Dockin' Competition or the evening Concert in the Park festival with the Lighted Boat parade held on September 27, 2025; I/We, individually, and if a partnership or corporation, on behalf of, will:

- Comply with all rules, regulations, and standards established or imposed by the HDG Extreme Boat Dockin' &
  Riverfront Festival which affect, relate to, or prescribe the manner of set up, maintenance, health & safety, operation
  and conducting of business at my booth at the 2025 festival. My signature on this document and/or my submission of
  an application to participate as a vendor constitutes my knowledge of, understanding of and consent to comply with
  all rules, regulations and standards. Failure to comply could result in expulsion from current and/or future festivals
  sponsored by HDGinBloom.
